### About the Position

The Regional Planner supports BHRC's efforts to help Northwest Illinois respond to and recover from the impacts of the COVID-19 pandemic and support long-range planning, economic resiliency, and natural resources conservation.

### Working Environment

Under the direction of the executive director. Hybrid office/remote work and flexible work hours are available. Willingness to travel to and work in the field and throughout the six-county region is critical. Approved mileage, cell use, and professional development are reimbursable.

### **Essential Functions**

- Develop and manage plan update projects for local units of government, including:
  - o Economic resiliency plans that incorporate quality of life issues
  - Comprehensive plans
  - Hazard mitigation plans
  - o Housing development and community infrastructure plans
  - o Greenways and trails plans
- Facilitate water resources planning, conduct water resources research and analysis, organize related stakeholder meetings, draft recommendations for local stakeholders, the Illinois State Water Survey, and the Illinois Department of Natural Resources
- Update the Comprehensive Economic Development Strategy (CEDS) for Northwest Illinois to address economic resiliency and quality of life issues, including those related to the COVID-19 pandemic



- Build and maintain relationships with local units of government and support their implementation of CARES Act and American Rescue Plan Act programs
- Other project development, grant writing and administration, grant compliance and oversight
- Track implementation progress and report regularly using standard forms
- Work closely with BHRC staff and participate at BHRC Board of Directors meetings
- Additional responsibilities and tasks as assigned
