## **About Us**

As Northwest Illinois' not-for-profit regional planning organization and economic development district, BHRC engages in community and economic development, natural resources conservation, and planning in Carroll, Jo Daviess, Lee, Ogle, Stephenson, and Whiteside counties. We seek to improve the quality of life for communities and individuals.

## Implementing the CARES Act Locally

Following the passage of the federal Coronavirus Aid, Relief, and Economic Security (CARES) Act, Blackhawk Hills applied for and was awarded \$400,000 from the U.S. Economic Development Administration to help Northwest Illinois respond to and recover from the COVID-19 pandemic. Two significant pieces of BHRC's work plan have included on-site support services, namely indoor air quality (IAQ) testing and municipal/ neighborhood-level walkability assessments. To date, Blackhawk Hills' staff have performed dozens of IAQ tests at small business locations, not-for-profit organizations, and government facilities; further, we have worked with cities and villages to implement walkability assessments, including in communities like Mount Morris (Ogle Co),...

...Oregon (Ogle Co), Sterling (Whiteside Co), and Warren (Jo Daviess Co). Another area of pandemic response includes addressing quality of life issues more intensely, such as the availability of affordable, high-quality single and multi-family workforce housing. In early 2021, Blackhawk Hills and partners (e.g., economic development organizations, main street entities, workforce and housing agencies, local units of government, etc.) concluded an extensive request for proposals process, selecting Redevelopment Resources (based in Madison, WI) to study the state of housing and related investment opportunities in each of our counties. Other components of livability - such as recreation, public health, and multi-modal mobility - will be addressed in county greenways and trails planning, a process initiated by BHRC staff. In addition, we will continue engagement with government stakeholders concerning the state's Local CURE program and the recently enacted federal American Rescue Plan. Staff support in



2020 was behind some of our smallest communities' participation in Local CURE and businesses' pursuit of aid via various financial assistance programs.

## **Other Development & Technical Assistance**

Blackhawk Hills co-wrote Morrison (Whiteside Co) and the Illinois Fiber Resources Group's application for Connect Illinois funding to expand open-access broadband locally. We continue to support water resources and passenger rail planning, administer the Lee-Ogle Enterprise Zone, and facilitate participation in the Commercial Property Assessed Clean Energy (C-PACE) program. Ogle County represents the first county in the BHRC region to pass a C-PACE enabling ordinance. Additionally, with Northern Illinois University as a partner, we secured funding for local foods research on specialty crop aggregation and other topics impacting smaller farmers and independent restaurants.
